Pricing and Cancellation Policy

Pricing Policy:

Online Registration will be available on June 19th, 2017 (8:00am MDT). AFCI Members in good standing may choose to pay at the time of registration via credit card (Visa / MC) or check / wire transfer (to be invoiced by the AFCI office). Members not in good standing and non-members will be required to pay at the time of registration via a credit card (the AFCI accepts Visa, MasterCard and American Express). Each attendee of Cineposium must register and pay the appropriate registration fee.

Early Bird Pricing will be available from June 19th, 2017 to July 23rd, 2017 (11:45pm MST). Early Bird Pricing for members in good standing with the AFCI will be \$750 USD. Early Bird Pricing for members not in good standing and non-members will be \$950 USD. Early Bird Pricing is available only for those registrations that are paid in full (PIF) by July 23rd, 2017. *Any registration that is invoiced and remains unpaid after July 24th will automatically revert to Regular Pricing.*

Regular Pricing will be available from July 24th, 2017 (12:00 midnight MDT) to October 15th, 2017 (11:45pm MDT). Regular Pricing for members in good standing with the AFCI will be \$850 USD. Regular Pricing for members not in good standing and non-members will be \$1050 USD. Regular Pricing is available only for those registrations that are paid in full (PIF) by October 15th, 2017. *Any registration that is invoiced and remains unpaid after September 18th will automatically revert to Late Pricing.*

Late and On-Site Pricing will be available online from October 16th, 2017 (12:00 midnight MDT) to October 22nd, 2017. On-Site Pricing will be available during the conference on the morning of October 21st, 2017 (time and exact location TBD). Late and On-Site Pricing for members in good standing with the AFCI will be \$950 USD. Late and On-Site Pricing for members not in good standing and non-members will be \$1150 USD.

*** Definition of "Good Standing": An Active, Interim, or Affiliate Member of the AFCI with no outstanding unpaid invoices (30 days or more past due) owed to the AFCI including AFCI Membership Dues. Cancellation Policy:

All cancellations received, in writing, before September 1st, 2017 (12:00 midnight MDT) will receive a full refund of all monies invoiced or paid less a \$100 USD processing fee. The processing fee will apply whether paid by credit card or invoice.

All cancellations received, in writing, between September 1st, 2017 and October 1st, 2017 (12:00 midnight MDT), will receive a 50% refund of all monies invoiced or paid, less a \$100 processing fee. The processing fee will apply whether paid by credit card or invoice.

All cancellations received, in writing, after October 1st, 2017 will **not** receive a refund of any monies paid or invoiced. Any unpaid registration fees shall remain payable to the AFCI.

No Shows: Failure to check-in at the conference will not void your registration and all applicable fees shall remain payable to AFCI.
